Entry Information, Deadlines, and Scratch Refund Policy:

Entries will not be accepted without payment.

- Open date for entries: **December 19, 2025.**
- The due date for entries: **January 23, 2026.**
 - It is suggested to send entries in ASAP, shows can fill up fast!
 - Entries **received** after the due date may not be accepted.
- The Closing Date is: **January 30, 2026.** As of this date, the program will be published and any changes after the closing date will not be in the official program and will be hand written in at the coaches meeting.
- ENTRY FEES:
 - If the rider is showing only 1 day: Entries are \$90/class plus a \$10 office fee per class, **for a total of \$100 per class.** (EWD entries are \$70/class plus a \$10 office fee per class, **for a total of \$80 per class.**)
 - If the rider is showing both days: The first day's entry fees still apply (see above). The second day's entry fees will be \$45 per class plus a \$5 office fee per class, **for a total of \$50 per class.** (A rider showing both days would be \$150 PER CLASS for the weekend). (EWD entries are \$35/class plus a \$5 office fee per class, **for a total of \$40/class.** An EWD rider showing both days would be \$120 for the weekend).
 - **The office fee will not be refunded in the event of a pre or post close date scratch.**
- **R40.04** Number of Entries and Limiting Entries
 - **No show should exceed 250 rides per day.** Entries will only be considered accepted once originals are received with horse description (or rented ride payment) and total payment for entries. Emailing entries is helpful, however this will not be considered an official entry until payment is received. In the event that the maximum entries are reached, entries will be accepted on a first-come basis (when received with payment).
 - **Teams are limited to 42 total entries between Jr and Sr high teams.** EWD, Pearl and Alumni entries do not count toward the total number of entries (R1.01 B) Show committees may accept additional entries in the Jr and Sr high divisions from teams if the show has not exceeded the maximum number of entries by closing date (January 16, 2026), as long as it is done in a fair and equitable way.
- In the event you have a scratch prior to the closing date (January 30, 2026), use [Scratch and Refund Request Form](#) to ensure a full refund (less the office fee). Remember, this document needs to be completed in its entirety AND **received** by the show secretary by 5:00pm of the closing date to ensure a refund. Entry fees for scratches occurring after the closing date/time, will be refunded only under extraordinary circumstances. If you feel your rider/s circumstances rise to this level, you may complete a [Scratch and Refund Request Form](#) located under *Coaches Forms* on the YEDA Website.

Rent and/or Provide a Horse:

R12.05 Horse ratio requirements per type of show:

Double Judged Show: Teams are required to bring **one (1) horse for every six (6) entries**, unless the host team reduces the team's horse entry ratio because of space or entry limits. Horses that are considered height weight horses as defined (R16.01-B & C). Show management, when necessary, has the discretion to reduce the number of entries/rides height weight horses to less than 6.

If you are unable to provide enough horses to meet the needs of your entries, you may rent rides at the cost of **\$50 each**. ***Rented ride fees are not refunded after the close date.***

Height/Weight:

Please take note of the **height/weight** notification box. The show committee will follow the YEDA rulebook (R16.01-B & C) suggestion for Height/Weight riders. The limits for **slight/older horses will be 5'9" – 160lbs**. Height weight for **Ponies 12.3 to 14.2 it is 5'5" – 125lbs**. If the rider exceeds either of these limits, please mark the appropriate check box on the entry form. This will bring the rider to attention so that the rider's height and weight can be observed in the database.

This same column is also offered on the **horse description page to note which horses need to be height/weight horses**. Horses who are height/weight horses are horses whom it is bad for their health or carry a rider of a size greater than **5'9" – 160lbs**. Or a pony between the size of **12.3 to 14.2**, will have the limits of **5'5" – 125lbs**.

Diamond Elite:

The Diamond Elite class may be offered at this horse show. Opportunity to participate will be offered to teams based on the most accumulated team points (posted online as of the entry due date, January 23, 2026) until the class is full. Those teams will receive an email invitation before the show explaining that they have been invited to participate in the Diamond Elite class. If a team who has qualified chooses not to participate then the invitation will be offered to the next team in line according to points.

Entries for the Diamond Elite will be accepted at the show, with full payment.

EWD Riders will have the option to show two classes. They can choose to show both classes or one class.
